- We also found out from the MTA each time we do a text amendment it will need to also go through the process of becoming an individual Ordinance with an assigned number.

 - 1. Individual Police Ordinances and the Zoning Ordinance should refer to a range for any penalty. It will give the Judge some guidance. Tom York will also inform the Board of this item. *Example:* "Not less than \$100 but no more than \$500."

b. Page 80 G.5 is one place in the Zoning Ordinance that could have a violation amount, or refer to an individual Police Ordinance?
