- Ordinances status with Twp Board ask Zoning Administrator (Supv.)
- Other Future Meetings, Outside, Time, Virtual, Etc. With cooler weather expected, Big room in Hall capacity is 180 so 36 people would be able to social distance.

Public Comments – Al Anger questioned why a home on 8 mile had no permits or septic and had multi dwelling units for almost 3 years with no Code violation or zoning enforcement. He suggested using the County Sherriff to ticket violations as is done in other townships. Board member responded that board would have to motion and approve vote to get sheriff to enforce.

Rick outlined – talk to offender, allow 30 days to respond, verify action then ticket if no improvement, then court hearing.
